

St. Austin Catholic School 2012-2013 Financial Aid Information



St. Austin Catholic School (SACS) offers a limited amount of tuition assistance to active St. Austin Catholic Parish (SACP) families who have experienced financial hardships. Applications for assistance are available on the school website or at the parish business office. Tuition assistance is considered on an annual basis and should not be expected if you have received assistance in a prior year. To be eligible for assistance, you must have completed one year at SACS. Tuition assistance applications are reviewed anonymously by the Financial Aid Committee.

Completed financial aid applications are due **Thursday, February 9, 2012 by 5p.m. in the parish office to the attention of Lisa Blackmon.** All incoming financial aid applications will be stamp dated upon their arrival in the parish office.
